This Subscription and the rights and obligations of the parties hereunder will be governed by and construed in accordance with the laws of the Province of Ontario and any legal action or proceeding with respect therein or hereto will be brought in the courts of the Province of Ontario.

The Subscriber hereby authorizes the Manager to correct any minor errors in, or complete any minor information missing from, the Form 45-106F4 (Appendix I), the Eligible Investor Questionnaire (Appendix II), or the Accredited Investor Certificate (Appendix III), if applicable, which has been executed by the Subscriber and delivered to the Manager. The Subscriber agrees to make, execute and deliver any and all further assurances or other documents necessary to give full force and effect to the meaning and intent of this Agreement, including any such documentation that the Manager may require to verify eligibility of the Subscriber under applicable securities laws and the Subscriber consents to the filing of such documents and any other documents as may be required to be filed with any securities regulatory authority in connection with the offering of the Class F Units.

## 9. Income Tax Legislation
